Draft Minutes for Meeting on April 14, 2025, 6:30 p.m.

OLD BUSINESS

- Natural Resources Mapping update Friedman
 - Lefebvre asked Friedman re. preliminary mapping timeline. Several aspects hinge on completion of trail info mapping. Draft in fall with full rollout in winter 2025-26.
 - Lefebvre shared Jaffrey CC's brochure on using NRI system
- Earth Day at Cathedral of the Pines, April 26 Dickler
 - o Commission discussed event schedule and commission assignments.
- Conservation Land & Related
 - o Trail Stewards update Rubendall
 - April Workday rescheduled to the 19th, corresponds with Trail Steward Orientation led by Rubendall. Trail Stewards will be invited to join workday sites.
 - Work Day volunteers will meet at 8am in parking area of Converse Meadows.
 - Roster of Trail Stewards was passed out, 14 listed.
 - Initial orientation will be held at Rindge Recreation pavilion on 4/19 at 9a.
 - County Road parking area Drouin
 - Parking area improvement plan to level parking area, square off area around kiosk
 - Paul Knight has offered to donate the labor, RCC will purchase materials.
 - Drouin will set meeting with Knight to discuss scale of labor and materials.

NEW BUSINESS

- Invasive plants Dickler with Carol Fisk
 - Carol Fiske attending to discuss options for invasive plants at RCC properties
 - Proposal to do invasion and/or invasive plant inventory at one or more RCC properties to identify species and/or make assessment for removal. Plan included three options with one property being surveyed in 2025. Commission in agreement and discussed which property should be reviewed first to prove the process.
 - Decision to first survey Contoocook property
 - Initial costs include: print, paper, google plant identifier
- CLAPA Membership
 - Contoocook Lake Area Preservation Association approached RCC and asked to renew membership in the amount of \$55. Dues help support lake water quality tests, millefoil mitigation in cooperation with DES.
 - Commission decided against membership for 2025/26.
- FPU Internships Rogers
 - President Eden has requested expansion of internship opportunities locally in Rindge. FPU environmental science faculty would like to set up internship program for 2026-on with RCC and requested to present at 2nd meeting in May to discuss, led by Rogers. Commission supported idea and discussed opportunities for a student intern.

 - o Drouin will follow up with letter to Planning Board with acceptance while expressing close proximity to guard rails and noting the change in easement for walking access to common land.

 Residential Agricultural District Section 2 of the Wetlands Ordinance to permit a stone retaining wall to be built within the 50' setback
 - Presented by Mr. Kenyon Salo, husband of Carmela Salo of above revocable trust. Request to approve permit to bring project already completed into compliance. Commission had previously conducted site visit on November 12, 2023.
 - Drouin will draft letter to ZBA supporting the application to bring the completed project into compliance.
- ZBA Case 2025-05 Special Exception King's Way LLC 58 Mark Street Map 6 Lot 73-6 Residential Agricultural District - Section 4.G of the Wetlands Ordinance, meets Special Exception criteria from Article XV section B of the Zoning Ordinance
 - o Presented by Kirk Stenerson with discussion from the commission
 - Commission reviewed the application with no discussion from public in attendance. Commission voted to draft a motion favorably to ZBA for consideration.
