



**BOARD OF SELECTMEN  
MEETING MINUTES  
July 6, 2022**

**Present:** Bob Hamilton, Chair, Marybeth Quill, Vice Chair, and Karl Pruter, Selectmen; Laurie May, Finance Director, Amanda Urmann, Executive Secretary; and members of the public.

Public session opened at 5:30 pm. Bob motioned to enter non-public session pursuant to RSA 91-A:3, II(a)(b)(c)(j). Second by Marybeth, motion passed 3-0.

**Selectmen announcements:**

## 1. Old Business

### a) ARPA

Bob spoke to Mike and asked if he wanted to move forward with the septic systems for the town building and the Meetinghouse. What is needed to be done first is to get someone to come out and design the septic system but they first need to find where it is and all that is included with starting the process before they can even come up with a cost.

The Board to encourage Mike to start this process.

### b) ADDED AGENDA ITEM: Town Oil Propane Bids

Mike also was brought up for this, and it was mentioned that it was uncertain if oil companies would even lock in at prices due to the uncertainty of prices currently.

Mike has a friend in the industry that is willing to help advice as to what to do for the future of this.

## 2. New Business

### a) Assessing RFP

This is a request for proposal for an assessing company to draw up bids to assess to town. This will need to be something that starts being looked into soon.

## 3. Informational Items/Communications/Updates

The Roadway Committee met and they made a recommendation on the cell tower on Bemis Tavern Road. They got approval for this cell tower but now the company who is putting this tower in needs permission to be able to upgrade and maintain the road so that they can get to this road and that the fire department can access to and from it. They're looking for about 160 feet worth of upgrade and maintenance. A public hearing will be held at a further date in regards to this and will be posted and mailed out as appropriately.

The Planning Board met as well and have approved 6 more storage buildings on Route 202.

There was a lot line adjustment approval on a subdivision on 3 lots on Middle Winchendon Road and Route 202.

The gas mileage rate has been raised from .58 cents per mile to .62 cents per mile.

Bob motioned to go back into non-public session pursuant to RSA 91-3:A II(c) and (b). Karl seconded. 3-0

Public session reopened at 6:45pm.

Bob motioned to seal Sessions #4 and #5. One is for reputation and the other is for hiring may adversely affect the outcome. Karl second. 3-0
