# Draft Minutes for Meeting on January 9, 2023

Meeting Convened at 7:00 pm

Members present: David Drouin, Al Lefebvre, Phil Simeone, Rob Rubendall, Fred Rogers, Doreen Richards Alternate members present: Fred Dodge

## **OLD BUSINESS**

Mattabeseck Wildlife Corridor Update - Lefebvre reported that Rick Van de Poll had visited with him on • January 6 to view the progress on the parking area created by Jay Pittorino of Rindge Stone & Gravel. He wanted the Commission to know that he was impressed with what has been accomplished including the new kiosk. The drainage was placed just the way it had been designed and was working accordingly.

Drouin noted the stone/gravel placed in front of the kiosk by Rindge Stone & Gravel which leveled the area. He also noted the plowing that Rindge Stone & Gravel had done in the new parking area after the last storm of heavy snow.

- Monitoring of conservation lands Rubendall reported that he had visited Converse Meadow to see how the heavy snow had affected trails after being bent over and found that all the trees had popped back into position as a result of the melting. He also walked to the tenting area which had no snow damage and agreed that moving the bridge up the trail would make it easier for walkers.
- Wetlands report Richards asked about the status of the wetlands report and will contact Van de Poll for more information.

## **NEW BUSINESS**

- POOR Meat Raffle for February 4 sign-up Lefebvre reported that the Commission is committed to this • meat raffle. Eight volunteers are needed from 1:00 to 5:00 pm; two able-bodied volunteers are needed early to move meat from the freezer; 2 to validate tickets and 4 to wear ticket belts. All volunteers need to stay at the raffle to the end. So far, the following have volunteered: Drouin, Richards, Rubendall, Linda & Fred Dodge, Lefebvre. Lefebvre will contact the Conservation Corps for additional volunteers.
- Review of response to Minor Site Plan at Map 4 Lot 38, 233 NH Route 119, John Melehov. Drouin re-• viewed with the Commission this site plan.
- Discussion of RCC 2023 projects or RCC 2023 schedule. The Commission reviewed the needs of each conservation area and will be discussed at the next meeting. The summary will be reviewed at the next meeting and work on a proposed schedule of 2023 activities.

#### Rindge Conservation Commission **Proposed Work Projects for 2023**

- <u>Converse Meadow</u> Move bridge about fifty feet further up and along trail to camping site.
- <u>Tetreault Park</u>
  - Improve trail marking especially at trail intersections
  - Consider possible bridge in wetland area
- Schoolhouse Park
  - Build and place two benches at key visitor locations.
- Hunt Town Forest
  - Build and place two benches at key visitor locations.
  - Improve trail that goes to top of hill from along right side of main trail
  - Perform more trailblazing
- Ford Wildlife Preserve
  - Install property posts near pond's edge to clearly identify Town land
  - Build bridge across gully near McPhie bench
  - Post more information at kiosk
  - Build and place bench at key visitor location
- <u>Town Forest</u>
  - Build and place benches at brook, top of hill, pollinator area, area overlooking wetland.
  - Install stairs at switchback area
  - Install culverts in wetlands
  - Reseed pollinator area
  - Post or update information kiosk information

- <u>Contoocook Conservation Complex</u>

  - Brushing needed along trails
  - County Rd kiosk needs improvements
  - o Move old Kiosk in wetlands at trailhead area nearer to rails-to-trails
  - Install nature signage in loop (using funds from grant and Conservation Fund).
