SB 411 relative to the merger of lots that are mortgaged and the restoration of involuntarily merged lots.

Chapter Law 327

This bill amends RSA 674:39 to require applicants for voluntary merger of lots to give notice to mortgage holders and requires the planning board to approve merger applications on condition that mortgage holders consent; when recorded, the mortgage applies to all lots involved in a merger; also planning boards shall not approve a merger that creates a violation of a current ordinance or regulation; the bill also amends RSA 674:39 aa to extend the deadline to restore involuntarily merged lots to December 31, 2021 instead of December 31, 2016. Effective date: August 23, 2016.
